ORDINANCE 1205-01-2019

AN AMENDMENT TO ORDINANCE 7-1-21 KEEPING OF DOMESTICATED CHICKENS REGARDING THE NUMBER OF CHICKENS PERMITTED IN SUBSEQUENT YEARS VILLAGE OF NEOSHO MUNICIPAL CODE

The Village Board of the Village of Neosho, Dodge County, Wisconsin, does ordain as follows:

7-1-21 KEEPING OF DOMESTICATED CHICKENS.

Section 1: Subsection (c) Procedure Governing Permits, (4) is amended as follows:

(c) Procedure Governing Permits.

(4) Each permit, during the first year of the permit, shall allow the keeping of no more than four (4) wing clipped chickens in strict compliance with the conditions set forth in subsection (d).
Subsequent years allow for up to (8) eight chickens.

Section 2:

This ordinance shall take effect upon passage and posting.
