16-1-2 UNLAWFUL CONDUCT PROHIBITED.

It shall be unlawful for any person to commit any of the following acts in or upon any public park within the village.

- (m) **Camping Regulated.** No permanent camping is permitted in Village parks. However, camping for a single night is permitted upon written permission from the Police Department.

ORDINANCE 0806-01-2020

AN ORDINANCE AMENDING PARKING RESTRICTIONS 10-1-06, PARKING RESTRICTIONS, IN THE VILLAGE OF NEOSHO MUNICIPAL CODE

The Village Board of the Village of Neosho, Dodge County, Wisconsin, does ordain as follows:

SECTION I: (c)Parking Prohibited at all Times:

Addition of:

(4) On Hale Road – No Parking on the South Side of the road from the Westerly Village Limits to the 288 feet West.

(4) On Hale Road – No Parking on the South Side of the road from the Westerly Village Limits to the 325 feet West.

SECTION II: PENALTY.

Any person who shall violate any provision of this chapter may be subject to a penalty as provided in Sec. 1-1-6 of this code.

SECTION III: This ordinance shall be effective upon its passage and publication.
