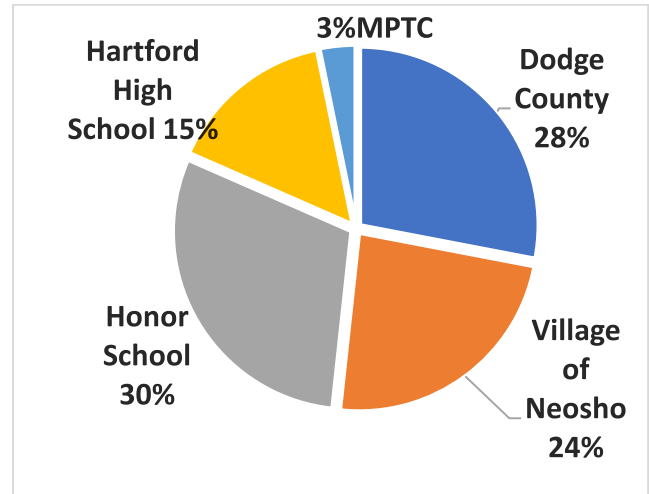


2020 Village of Neosho Taxes

If you have a question in regards to your property tax bill you may call, 920-625-3086 or email the Village at neoshovillage@frontier.com.

As you view your property tax bill remember that your tax bill is divided among five taxing jurisdictions: Dodge County, Village of Neosho, Herman/Rubicon/Neosho School District, Hartford Union High School, and Moraine Park Technical College. The tax amount is calculated by multiplying the tax rate by the assessed value, and then adjusting for tax credits. If you have a question about your assessed value, call the Village Assessor, Grota Appraisals at 262-253-1142.



Tax bill payments can be mailed to: Village of Neosho Treasurer, PO Box 178, Neosho WI 53059-0178.

The Village has a drop box in front of the Village Hall Door for payments. A receipt will be mailed back to you for your records.

Dog Licenses are taken care of at the Village Hall. Dog Licenses are required per state statute. Dog Licenses are \$10 for altered dogs and \$15 for non-altered dogs. Dog licenses expire December 31. If not licensed by March 31st there is a \$5 late fee. If paying for dog license with taxes the rabies certificate will be returned with your receipt and dog license.

Horicon Bank will **not** be collecting tax payments. Thank you to Horicon Bank and their staff for the years of collections.

If you have an escrow check make sure all parties have signed the back of the check. Make checks out to the Village of Neosho. A receipt and refund if applicable will be mailed to you.

Dodge County Enhances 9-1-1 Services and Emergency Notification with **Smart911**. Smart911 allows individuals to create a Safety Profile for their household at www.smart911.com or on the Smart911 App that includes any information they want 9-1-1 and response teams to have in the event of an emergency. When a citizen makes an emergency call, their Safety Profile is automatically displayed to the 9-1-1 calltaker, allowing them to send the right response teams to the right location with the right information.

The Village will charge a \$20 rental fee per day for reserving either park pavilion. You may reserve the park pavilion by calling 920-625-3086 or by emailing neoshovillage@frontier.com. The Village will charge a \$5 per day boat launch fee. An annual permit is also available.

Woodlawn Cemetery now offers Plots for Urn use. To reserve your plot call the Village Hall at 920-625-3086.

The Village Caucus will be held on **January 7, 2021 at 6:30 p.m.** Watch for notices on villageofneosho.org. The Spring election will be held on **April 6, 2021**. If there is a primary it will be held on **February 16, 2021**.

Watch the Village Website for the **Recycle and Garbage pick up dates**. The full schedule has not been released from Waste Management / Advanced Disposal. Your tax bill does include a charge for recycling and refuse pick up.

Real Christmas Tree pick up has been scheduled for **January 8th & possibly January 9th**. Please have your tree out at the curb by **January 8th 6 am**.

Snowmobile Races are scheduled for **February 13th**.
