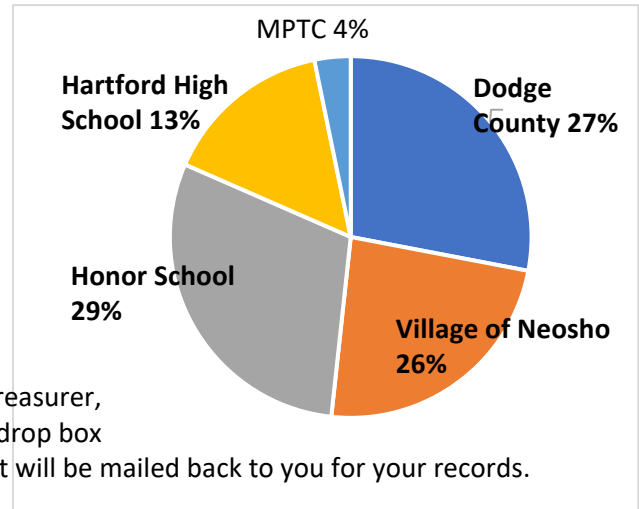


2024 PROPERTY TAX

VILLAGE OF NEOSHO

If you have a question in regard to your property tax bill you may call, 920-625-3086 or email the Village at neoshovillage@frontier.com.

As you view your property tax bill remember that your tax bill is divided among five taxing jurisdictions: Dodge County, Village of Neosho, Herman/Rubicon/Neosho School District, Hartford Union High School, and Moraine Park Technical College. The tax amount is calculated by multiplying the tax rate by the assessed value, and then adjusting for tax credits. If you have a question about your assessed value, call the Village Assessor at 262-253-1142.



Tax bill payments can be mailed to: Village of Neosho Treasurer, PO Box 178, Neosho WI 53059-0178. The Village has a drop box in front of the Village Hall Door for payments. A receipt will be mailed back to you for your records.

Dog Licenses are taken care of at the Village Hall. Dog Licenses are required per state statute. Dog Licenses are \$8 for altered dogs and \$12 for non-altered dogs. Dog licenses expire December 31. If not licensed by March 31st there is a \$5 late fee. If paying for dog license with taxes the rabies certificate will be returned with your receipt and dog license.

If you have an escrow check make sure all parties have signed the back of the check. Make checks out to the Village of Neosho. A receipt and refund if applicable will be mailed to you.

Upcoming Projects: There is a proposed construction project planned in 2030 for State Hwy 67 by the Wisconsin Department of Transportation. The state is in the pre-planning process of the project.

The Village Board has adopted a monitoring plan for the dam and is working with the Wisconsin DNR and an engineer. There is a draw-down slated for 2025 to further inspect the gate and dam. There is an account at the Horicon Bank set up specifically for the dam as well as a go fund me page for the dam. This funding is set aside specific for the dam maintenance and repair.
