MEETING OF THE VILLAGE BOARD OF NEOSHO

March 3, 2025

President Oldenhoff called the regular meeting of the Village Board of the Village of Neosho to order at 6:00 p.m. Present were President Oldenhoff, Desmore, Kelsey, Rodriguez (6:11 p.m.) and Weynand.

Adoption of the February 6, 2025, minutes.

Motion (Weynand/Desmore) to approve the minutes. Motion carried unanimously.

Public Appearance and Comments.

None.

President Report.

President Oldenhoff reported that the DOT repair of Hwy 60 to Goodland Road. President Oldenhoff reported that this will happen after July 4th, of 2025; to be completed. President Oldenhoff will contact the DOT about contacts to the businesses and schools. June 14 and 15 will be the watercross event. EMTs are needed for that weekend. The boat launch will be shut down on June 14 and June 15. The beautification committee is needed that week prior. Concession stand help, parking lanes. There needs to be a committee and group to start forming the group. Brenda Conley is always looking for service projects for the 4-H. Have the 4-H assist with flags.

Approval of Financial Report with Comparisons and Payment of Bills.

Motion (Rodriguez/Kelsey) to approve the financial report. Motion carried unanimously.

Fire & EMS Report

Fire Department report was read by President Oldenhoff. Village Board reviewed the report.

Police Department Report.

The Police Statistics Report was read by Assistant Police Chief Linzenmeyer. Discussion ensued of the timing of the no parking and increase of ticket fine. Engine braking issue is continuing. Need additional engine braking sign with ordinance. Suggested DCert for the watercross event. West Lehman speeding is being watched.

Cemetery Sexton Report.

No report. There is a project for the kids in April 23rd in the cemetery.

Property Maintenance / Weed Commission Village Board Report.

Discussion ensued of the cleaning up along the rip rap and beach. Once the brush is down the Village President will take care of the weeds.

Motion (Rodriguez/Weynand) to take items out of order for Presentation by 99th Assembly District State Representative Barbara Dittrich assistance for Village of Neosho projects including the dam needs. Motion carried.

Village President Oldenhoff read a history bio of the Neosho community area. Surrounded by the Township of Rubicon and the pond runs through the Village for water recreation. The water also draws a lot of birds and wildlife. The dam controls the waterway. The Village owns the dam. The HNR school is in the Village limits. This is part of the school district with Saylesville and Rubicon. The Neosho Fire Department and Rescue is located in the Village of Neosho. The Neosho Rubicon and Ashippun Police Department are also in the Village. The Neosho BP, On the Rocks, K-9 Police Dog Training, Horicon Bank, Cool Cat Vintages, and Kelsey Amazon / Ebay business. The Neosho BP and On the Rocks assist with the Village with fundraising and support. There are three churches in the Village. One of the churches hosted a fundraising event. There is a historical museum by the dam.

The Village is requesting assistance from the State for the dam repair project and maintenance. Looking for a state budget motion. Grant dollars if we cannot get the budget motion. The Village did apply for the DNR Grant and did not receive the grant.

President Oldenhoff commented that the drawdown will start on August 8; the inspection will be August 1. This was to happen in 2024. If the gate is bad then the repair is on.

The pond comes out of Pike Lake, to Hartford, then Neosho. Hartford had industry that left metals behind. Past soil samples show metals that would need to be dredged.

Discussion ensued of becoming a Town. The Village of Lac la Belle no where to go similar situation. Looked into a land annexation.

Tr. Weynand gave historical information of the Village and surrounding community.

Motion (Rodriguez/Kelsey) to go back to agenda order. Motion carried.

Clerk – Treasurer Report.

51 voters came out to vote on February 18. This is 12% turnout.
